An update was given on Resolution 19-12-02 Museum fund balance. Commissioner KNUDSON asked about the fund balance. Executive Director RESNICK replied that it has built up over the years and will be spent down.

Commissioner DOLAN asked about the Corporation and Recreation Fund balance estimates \$2,000,000 available at year-end. Executive Director Resnick said this was current and \$1,000,000 of that will go to the Capital Fund in 2020.

Commissioner KNUDSON asked about the Spray Park admission, why is it not free? We would save some money by not having a cashier.

Executive Director RESNICK asked does Board want spray park admission changed in the 2020 budget. Commissioner FRASIER suggested leaving it. Commissioner DOLAN suggested leave at 2019 rates. President ORTEGA stated no increase in admission. The Board agreed that Spray Park admissions should be \$1 for residents and \$4 for Non-residents.
