Rules for Public Comment:

- A. At the start of the period for public comment the board President or acting chairperson will advise the public:
 - 1. The amount of time permitted for public comment;
 - 2. That all speakers state their name and addresses before addressing the Board;
 - 3. To avoid repetitive comments, testimony and general questions; and
 - 4. To appoint only one person to speak on behalf of a group.
- B. Each person will be permitted to speak one time only, unless the President determines that allowing a speaker to address the Board again will contribute new testimony or evidence germane to an issue on the agenda for that meeting.
- C. Unless a representative spokesperson is appointed in the manner described in rule D, all comments from the public will be limited to no more than three (3) minutes per person.
- D. Groups may register a representative spokesperson by filing an appearance form no later than one (1) hour in advance of a meeting. The appearance form must designate (i) the number of people the designee represents for the purpose of making public comment; (ii) the subject matter of the public comments; and (iii) whether the subject begin represented by a group spokesperson shall be deemed to have waived their opportunity to speak independently unless the President determines that allowing such a speaker to address the Board will contribute new testimony or evidence germane to an issue on the agenda for that meeting.
 - 1. A representative spokesperson who timely files a complete appearance form to speak on a matter germane to the agenda shall be permitted to speak for three (3) minutes for each person being represented, up to a maximum of fifteen (15) minutes.
 - 2. A representative spokesperson who timely files a complete appearance form to speak on a matter not germane to the agenda shall be permitted to speak for three (3) minutes for each person being represented, up to a maximum of nine (9) minutes.
- E. The Board shall not respond to questions posed during public comment. All questions shall be recorded by the Board Secretary and a response shall be presented either during the next regular Board meeting or in writing before such meeting.
- F. All commends must be civil in nature Any person who engages in threatening, slanderous or disorderly behavior when addressing the Board shall be deemed out-of-order by the presiding officer and his or her time to address the Board at said meeting shall end.

Updates

Drawings of the proposed driving range at Steeple Chase Golf Club are enclosed. The number of hitting bays was reduced from 20 (10 per floor) to 16 (8 per floor). The boardwalk leading up to the structure was also reduced.

Just a reminder since the Board is used to seeing the Prevailing Wage Ordinance in June. The law has changed and we are no longer required to adopt an ordinance. We are still required to notify bidders and contractors they are required to pay prevailing wage and we will need to collect certified payroll prior to making payment.

One property tax appeal was received for 155 S. Chicago Avenue. It is assessed at \$1,364,557 and they are requesting a reduction in value to \$1,264,558. The County handles all appeals on our behalf.

Action Items

Commissioner Patrick McGrath will be sworn in.

Annually staff prepares a Treasurer's Report. This is a statement of receipts and disbursements. This report is filled with the County after Board approval. Staff recommends approving the 2018 Treasurer's Report.

VW Credit in Libertyville has requested to rent the Diamond Lake Beach for a company picnic. This would include a DJ, bounce house, catered food, alcohol and admission to the Beach. The Board would need to approve a variance to allow alcohol. The Police Department will be consulted and their procedures followed.

Staff recommends approving a variance to allow alcohol at a private rental at the Beach.

For the past year staff has been working with an Interior Designer to guide us through a refresh of the Community Center. The next phase of the design plan calls for the removal of the display case, stone pillars and the maple wood trim in the main hallway. Staff has been working with Brown & Root Construction Company on the build out for the Nova Care Physical Therapy space and we would like to add this hallway work onto the current contract. District staff attempted to complete the work during May and determined they cannot complete the work within a timeline that does not interfere with the future business operations of Nova Care Physical Therapy and the community center programs and services. This request is for work that is different and in addition to the "spin room" contract that was requested at the May 13 Board Meeting. This project will be paid for from funds budgeted for Community Center renovations.

Staff recommends approving a change to the existing contract with Brown & Root to have them complete the hallway renovation work at the Community Center in the amount of \$24,998.88.

Mundelein Park & Recreation District Committee of the Whole May 13, 2019

The Committee of the Whole meeting of the Board of Park Commissioners of the Mundelein Park and Recreation District was called to order at 7:00 pm by President DOLAN.

Present were Commissioners DOLAN, FRASIER, KNUDSON and ORTEGA. Staff present included Executive Director RESNICK and Superintendent of Business Services & Technology McINERNEY.

Executive Director RESNICK introduced Jamie Wiley from Lauterbach & Amen to discuss the Comprehensive Annual Financial Report (Audit) with the Board. She pointed out several highlights in the document and asked the Board if they had any questions. Commissioner KNUDSON asked if resident property values were still down. Ms. Wilkey said they have rebounded some, but not as quickly as commercial property values. President DOLAN asked about the change in long term debt. He was told the previous bond issue was paid off just after the new bond was issued. Ms. Wilkey said the poor performance of the IMRF investments also effects the District's net position because of potential liabilities. President DOLAN asked about the change in the bond rating. Ms. Wilkey said issuing additional debt may have affected the rating.

President DOLAN asked about the misfiling discovered during audit field work and the lack of mention. Ms. Wilkey said the auditors did not feel this was a pervasive issue and as the District did not exceed its legal spending limit, it did not need to be noted. President DOLAN asked about the Certificate of Excellence Award from the Government Finance Officers Association. Ms. Wilkey said it involved gathering additional information and that bond rating firms find helpful and recognizes agencies for transparency in their financial reporting.

There were no more questions and the Board thanked Ms. Wilkey for her presentation.

Executive Director RESNICK reviewed the first quarter financial report. President DOLAN said the new format was easy to read and gave the Board the information they needed.

The Board was updated on the staff succession meeting that was held. Commissioner ORTEGA suggested adding succession planning discussions to each staff member annual review.

The Committee Meeting adjourned at 7:30 p.m.

The regular scheduled meeting of the Board of Park Commissioners of the Mundelein Park and Recreation District, Mundelein, Lake County, Illinois, was called to order at 7:30 p.m. by President DOLAN and he asked the assemblage to rise and recite the Pledge of Allegiance.

He then directed the secretary to call the roll. Commissioners DOLAN, FRASIER, KNUDSON and ORTEGA were present. Staff present included Executive Director RESNICK.

Commissioner ORTEGA moved to approve the minutes of Committee Meeting, Regular Meeting and Executive Session of April 22, 2019 as corrected, second by Commissioner KNUDSON. President DOLAN repeated the motion and asked if there were any corrections or additions and none were made. A voice vote was taken with all voting yes.

Commissioner FRASIER moved to approve Warrants 042219, 042419, 043019, 050319, 050419, 050719 and 051319 in the amount of \$331,933.52 second by Commissioner ORTEGA. President DOLAN repeated the motion and asked if there were any questions and none were raised. A roll call vote was taken with Commissioners FRASIER, ORTEGA, KNUDSON and DOLAN voting yes.

Correspondence

President DOLAN said a letter was received from the Illinois Association of Park Districts thanking the Park District for participating in the Parks Day at the Capitol event. President DOLAN thanked Superintendent of Buildings & Grounds Solberg for attending the event and representing the District.

Old Business

During the Committee of the Whole Meeting, Jamie Wilkey from Lauterbach & Amen had presented the Comprehensive Annual Financial Report (Audit) to the Board. Commissioner FRASIER moved to approve the Comprehensive Annual Financial Report as presented, second by Commissioner KNUDSON. President DOLAN repeated the motion and asked if there were any questions and none were raised. A roll call vote was taken with Commissioners FRASIER, KNUDSON, ORTEGA and DOLAN voting yes.

The District will be modifying the space on the first floor of the Community Center for the NovaCare Physical Therapy space. Staff solicited pricing from Brown & Root through the National Joint Purchase program. Commissioner KNUDSON moved to approve a contract with Brown & Root for the Community Center room build out in the amount of \$69,892.95, second by Commissioner ORTEGA. President DOLAN asked if

there were any questions. Commissioner ORTEGA asked how much of the work was for the build out and how much was the Park District's responsibility. Executive Director RESNICK said NovaCare would be paying for \$49,000 of the work and the rest was for work being done to modify the spin room and would be paid by the Park District. A roll call vote was taken with Commissioners KNUDSON, ORTEGA, FRASIER and DOLAN voting yes.

Executive Director explained that the current name, Fort Hill Heritage Museum, was not something most people related to and it was recommended to change the name to Mundelein Heritage Museum. Commissioner ORTEGA moved to change the name to Mundelein Heritage Museum, second by Commissioner KNUDSON. President DOLAN asked if there were any questions and none were raised. A voice vote was taken with all voting yes.

President DOLAN asked the Executive Director to continue with updates from the Committee of the Whole Meeting.

Executive Director RESNICK reviewed the first quarter Marketing Report. President DOLAN asked that there be a summary on what the trends or data mean.

The Board discussed the possibility of the State of Illinois legalizing recreational marijuana. Commissioner ORTEGA asked staff to review the District's current policy and determine if modifications may be necessary. This way the District will be prepared to make changes quickly if necessary.

Executive Director RENSICK informed the Board there was one property tax appeal and that the Community Center would be closed May 23, 24 & 25 while the gym floor is being refinished. She updated the Board on progress with the driving range and outdoor ice rink. President DOLAN asked for updated drawings on both projects. The Board reviewed information from PDRMA about the benefits of membership. Information about the Executive Director's vacation time was shared and as well as a request for an Executive Session for the purpose of real estate and personnel.

New Business

Newly re-elected Commissioner Jesse Ortega was sworn in by the Executive Director.

President DOLAN explained that because this is the Annual Meeting of the Board, officer elections were to be held. President DOLAN moved to appoint Commissioner Ortega as President, Commissioner Frasier as Vice President and Commissioner McGrath as Treasurer, second by Commissioner KNUDSON. President DOLAN repeated the motion and asked if there were any questions and none were raised. A roll call vote was

taken with Commissioners ORTEGA, McGRATH, FRASIER, KNUDSON and DOLAN voting yes.

President ORTEA stated with the change in Human Resource Manager, a new FOIA Officer needed to be appointed. Pat Bruno said he lived near the 6th hole at Steeple Chase golf course and there was a large willow tree on the golf course that was causing damage to his landscaping. He asked that something be done about this. Staff will look at remedies.

Commissioner KNUDSON moved to adjourn to Executive Session at 7:56 p.m. pursuant to Personnel 5 ILCS 120/2 (c)(1) and Purchase or Lease of Real Estate 5 ILCS 120/2 (c)(5), second by Commissioner FRASIER. A roll call vote was taken with Commissioners KNUDSON, FRASIER, DOLAN and ORTEGA voting yes.

The Regular Meeting reconvened at 8:25 pm.

There being no further business, Commissioner DOLAN moved to adjourn at 8:25 p.m. second by Commissioner KNUDSON. The motion was unanimously approved.

Park District Report -April 2019

There were five (5) calls for service in the area parks during the reporting period, which is lower than normal with park district activity during this time of year. The majority of the calls were minor in nature and included an accidental damage to property report, animal complaint, burglary alarm, found item and a field interview.

Due to programs Issues Park checks by officers were unavailable for this time period.

The following gives more detail about the call during the reporting period:

- On 04/03/19, CSO Catinella responded to Diamond Lake Beach for an animal complaint. Upon arrival she took possession of the stray dog and transported it back to the police department. The dog was placed in a kennel and later turned over to its owner.
- On 04/05/19, Officer Sexton responded to Hanrahan Park for juvenile problem. Officer Sexton made contact with four juveniles and one was cited for possession of drug paraphernalia, possession of cannabis and possession of tobacco products. All four subjects were turned over to their parents.
- On 04/19/19, CSO Peterson responded to Community Park for an accidental damage to property report. Subject's son opened the car door striking the complainants vehicle.
- On 04/23/19, Sergeant Seeley responded the Mundelein Police Departments lobby for a found item report. The complainant turned in a set of keys located at Memorial Park. The keys were later placed into evidence.
- On 04/24/19, Officer Devore responded to Community Park for a burglar alarm. The alarm was set off in error by the cleaning crew.

Officers will continue to perform walk-throughs at Park View for community building efforts, especially during open gym hours. In addition, they will continue to perform park checks at the various parks.


