Mundelein Park & Recreation District Committee of the Whole May 23, 2016

The Committee of the Whole meeting of the Board of Park Commissioners of the Mundelein Park and Recreation District was called to order at 7:00 p.m. by President KNUDSON.

Present were Commissioners DOLAN, FRASIER, KNUDSON, McGRATH and ORTEGA. Staff present included Executive Director RESNICK, Superintendent of Recreation KIPP, Golf Operations Manager BROLLEY, Golf Course Superintendent DORUFF, Superintendent of Parks SOLBERG and Business Manager MILLER.

Executive Director RESNICK said Jamie Wilkey from Lauterbach and Amen would present the 2015 Audit to the Board. Ms. Wilkey said the audit was clean and there were no recommendations in their letter. She explained to the Board the effect GASB 68 had on the District's financial statements. This new regulation requires the District to show IMRF pension liability. Commissioner DOLAN asked if the District had any control over the rate we are required to contribute on behalf of employees. Executive Director RESNICK said this rate is dictated to the District by IMRF and fluxuates year to year.

Ms. Wilkey thanked staff for their assistance in preparing the audit.

Executive Director RESNICK reviewed two options for issuing bonds in 2016 or 2017 to ensure the tax rate remains stable. Commissioner DOLAN said he had concerns about the state legislature taking away the District's ability to borrow funds and that it may be better to issue all that is allowable rather than issue some now and hope we can issue the remainder later. Tom Chapman from Raymond James will be asked to attend the next Committee Meeting to discuss additional options.

The Committee meeting adjourned at 7:30 p.m.

The regular scheduled meeting of the Board of Park Commissioners of the Mundelein Park and Recreation District, Mundelein, Lake County, Illinois, was called to order at 7:30 p.m. by President KNUDSON and he asked the assemblage to rise and recite the Pledge of Allegiance.

He then directed the secretary to call the roll. Commissioners DOLAN, FRASIER, KNUDSON, McGRATH and ORTEGA were present. Staff present included Executive Director RESNICK, Superintendent of Recreation KIPP, Golf Operations Manager BROLLEY, Golf Course Superintendent DORUFF, Superintendent of Parks SOLBERG, and Business Manager MILLER.

Commissioner DOLAN moved to approve the minutes of the Committee Meeting, Regular Meeting and Executive Session from May 9, 2016, second by Commissioner ORTEGA. President KNUDSON repeated the motion and asked if there were any corrections or additions and none were made. A voice vote was taken with all voting yes.

Commissioner FRASIER moved to approve Warrants 051016, 051716, 051816, 052016, and 052316 in the amount of \$423,782.09, second by Commissioner McGRATH. President KNUDSON repeated the motion and asked if there were any questions and none were raised. A roll call vote was taken with Commissioners FRASIER, McGRATH, DOLAN, ORTEGA and KNUDSON voting yes.

Commissioner DOLAN moved to place the April financials on file, second by Commissioner FRASIER. President KNUDSON repeated the motion and asked if there were any questions and none were raised. A roll call vote was taken with Commissioners DOLAN, FRASIER, McGRATH, ORTEGA and KNUDSON voting yes.

President KNUDSON said thank you letters were received from State Senator Dan McConchie and IAPD Executive Director Peter Murphy.

President KNUDSON said Lauterbach and Amen have prepared the 2015 Audit and reviewed it with the Board. The Audit was "clean" and no recommendations were submitted. Commissioner ORTEGA moved to accept the 2015 Audit as prepared by Lauterbach and Amen, second by Commissioner McGRATH. President KNUDSON repeated the motion and asked if there were any questions and none were raised. A roll call vote was taken with Commissioners ORTEGA, McGRATH, DOLAN, FRAISER, and KNUDSON voting yes.

President KNUDSON said staff was recommending changing the membership structure and pricing for Park View Health & Fitness. Commissioner FRASIER moved to approve the new membership structure and pricing for Park View Health & Fitness as presented by staff, second by Commissioner DOLAN. President KNUDSON repeated the motion and asked if there were any questions, and Commissioner ORTEGA asked about the change in the non-resident rate. Superintendent of Recreation KIPP said the non-resident rate is still higher then resident rate, but the variance is not as great. Commissioner DOLAN asked about the group exercise membership. Community Center Manager NUDO-SEMSAK said research showed most clubs in the area offered this option and it would make Park View more competitive. A roll call vote was taken with Commissioners FRASIER, DOLAN, McGRATH, ORTEGA and KNUDSON voting yes.

President KNUDSON said facility rental rates had not been increased since 2007 and staff is recommending changes to the rental fees for the Regent Center, Chalet and Indoor Pool. Commissioner FRASIER moved to accept the new rental fees as recommended by staff, second by Commissioner DOLAN. President KNUDSON repeated the motion and asked if there were any questions, none were raised. A roll call vote was taken with Commissioners FRASIER, DOLAN, McGRATH, ORTEGA and KNUDSON voting yes

Commissioner DOLAN said he attended the Village's TIF meeting. They will be moving forward with the restructure of TIF I and the creation of TIF II. The Village feels this is necessary to offer incentives to developers.

Staff Reports

Golf

President KNUDSON asked if the wet weather was affecting golf rounds. Golf Operations Manager BROLLEY said yes but that when the weather is good, the golf course has been very busy. President KNUDSON commented on the great press coverage with the ABC Channel 7 feature of Steeple Chase. Commissioner DOLAN said he had heard positive feedback about the new hitting stations, but was asked why there were no tees in the turf. Golf Operations Manager BROLLEY said the turf was made to have real tees inserted. He will post signs to let customers know they can use a regular tee. President KNUDSON asked if Golf Now was still drawing golfers to the course. Golf Operations Manager BROLLEY said he feels it is and that Steeple Chase had the highest rating last year for use of the Golf Now discounted tee times. President KNUDSON asked what miscellaneous revenue includes in the Board report. Golf Operations Manager BROLLEY said this is mostly the loyalty program. Commissioner FRASIER asked why some areas of the course were wetter than others. Golf Course Superintendent DORUFF said there are some old clay drain tiles that may be breaking.

Commissioner DOLAN asked what the protocol is in June, July and August since the dogs are not used to chase the geese. Golf Course Superintendent DORUFF said the company will use remote control boats and lasers.

Parks

President KNUDSON asked about the MacLean Fogg volunteer day. Superintendent of Parks SOLBERG said he did not have a number of volunteers yet, but the group would be clearing out some wooded areas at Community Park. Commissioner ORTEGA asked how many volunteers we could accommodate. Superintendent of Parks SOLBERG said if there were more than one hundred, he was prepared to organize a second site. Commissioner DOLAN asked if the recent excellent safety check of electric panels completed for PDRMA was due to park district staff. Superintendent of Parks SOLBERG said some of it was due to original construction and some due to regular maintenance by staff. Commissioner DOLAN suggested some type of recognition for staff.

Recreation

Commissioner DOLAN asked how the dance recital went. Superintendent of Recreation KIPP said it went very well, there were no problems. Commissioner DOLAN asked if there was any particular reason for the recent resignations in the dance program. Superintendent of Recreation KIPP said it was just a coincidence. One was leaving for school, one for a full time job and one because the commute was too much. President KNUDSON commented that it was good to hear the software conversion was ahead of schedule. Commissioner DOLAN asked if there was any concern about the decline in some of the Park View numbers. Superintendent of Recreation KIPP said that was the reason staff is recommending the restructure of memberships.

Business Services

President KNUDSON congratulated staff on the clean audit. Commissioner ORTEGA commented that he liked the new format for reporting accidents.

President KNUDSON announced service anniversaries for Michaelene Amedio, 10 years; Dakota Duncanson, 2 years; Mike Gerton, 6 years; Brian Jeske, 2 years; Jon Karl, 16 years; Michael Krauleidis, 8 years; Nathan Neuwirth, 7 years; and Scott Ragland, 3 years.

There being no further business, Commissioner ORTEGA moved to adjourn at 8:02 p.m. second by Commissioner McGRATH. The motion was unanimously approved.

New Business

The District is required by State law to adopt a prevailing wage ordinance each year. This is the document that is shared with contractors when bids are awarded. The State has not published current wages past July 2015 and we have been advised by our attorney this is what should be included in the Ordinance. Once adopted, this Ordinance is filed with the Secretary of State and Department of Labor.

Staff recommends approval of Prevailing Wage Ordinance 16-06-01.

The 2015 Treasurer's Report is enclosed. This is a statement of receipts and disbursements for the District for last fiscal year. In the past, the Board needed to formally adopt this document and it was published in the newspaper. The law changed a few years ago and publishing in the newspaper is not required, but the Board still must approve the Treasurer's Report and a notice is published in the newspaper stating the Audit has been filed with the County and is available for review.

Staff recommends approval of the 2015 Treasurer's Report.

Community Center Manager Rose Nudo-Semsak budgeted for the replacement of a row machine, dumb bells, dumb bell rack, kettle balls and kettle ball rack. This was budgeted as a three year lease. The interest rate is 5.99% and would total \$1,596.12 over three years. Instead of leasing, staff is recommending a straight purchase. This will mean going over budget in this line this year, but nothing will be budgeted for the following two years as originally planned.

Staff recommends purchasing one Cybex Row Machine for \$3,754.63; one set of Umax Dumbells and Rack for \$9,626.67; and one set of Kettle Bells and Rack for \$3,296.90 from Midwest Commercial Fitness.

Updates

Tom Chapman from Raymond James will be at the Committee Meeting to discuss bond options with the Board.

A tax appeal was received for 452 Morris Avenue. The Assessor valued the property at \$359,630 and the owner claims the property is worth \$233,310. The County handles these appeals.

The District's Carp Fest did not have many participants, but it was a fun event that should garner some good press and I'm sure will grow next year.

The April Police Report is enclosed.

ORDINANCE NO. 16-06-01

AN ORDINANCE ADOPTING PREVAILING WAGE RATES TO BE PAID TO LABORERS, MECHANICS AND OTHER WORKERS PERFORMING CONSTRUCTION OF PUBLIC WORK FOR MUNDELEIN PARK DISTRICT, LAKE COUNTY, ILLINOIS

WHEREAS, the State of Illinois has enacted the Prevailing Wage Act, approved June 26, 1941, as amended, being 820 ILCS 130/0.01 through 130/12 (the "Act"); and

WHEREAS, the Act requires that during the month of June of each calendar year the Board of Commissioners of the Mundelein Park District investigate and ascertain the prevailing rate of wages, as defined in said Act, in the "locality" of the Park District for laborers, mechanics, and other workers performing construction of public works for the Park District.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Mundelein Park District, Lake County, Illinois, as follows:

SECTION 1: To the extent and as required by Act, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of the Park District is hereby ascertained to be the same as the prevailing rate of wages for construction work in Lake County as determined by the Department of Labor of the State of Illinois (the "Department") as of June 1, 2002, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department shall supersede the Department's June determination and apply to any and all public works construction undertaken by the Park District. The definition of any terms appearing in this Ordinance which are also used in the Act shall be the same as the definitions specified in the Act.

SECTION 2: Nothing herein is intended to apply or shall be construed to apply said prevailing rate of wages as herein ascertained to any work or employment performed on behalf of this Park District except public works construction to the extent required by the Act.

SECTION 3: The Park District Secretary shall publicly post or keep available for inspection by any interested party in the park district office this determination of prevailing rate of wages. A copy of this determination or of the current revised determination f prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: The Park District Secretary shall promptly file a certified copy of this Ordinance with the Secretary of State of Illinois in Springfield.

SECTION 5: Within thirty (30) days after filing a certified copy of this Ordinance with the Secretary of State, the Park District Secretary shall cause to be published in a newspaper of general circulation within the area a notice that this determination is effective and constitutes the determination of this public body.

SECTION 6: The Park District Secretary shall mail a copy of this Ordinance to any employer, to any association of employers, and to any person or association of employees, who have filed their names and addresses requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 7: If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

SECTION 8: All Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 9: This Ordinance shall be in full force and effect from after its passage, approval and publication as provided by law.

LAKE COUNTY

The following list is considered as those days for which holiday rates of wages for work performed apply: New Years Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Day and Veterans Day in some classifications/counties. Generally, any of these holidays which fall on a Sunday is celebrated on the following Monday. This then makes work performed on that Monday payable at the appropriate overtime rate for holiday pay. Common practice in a given local may alter certain days of celebration. If in doubt, please check with IDOL.

EXPLANATION OF CLASSES

ASBESTOS - GENERAL - removal of asbestos material/mold and hazardous materials from any place in a building, including mechanical systems where those mechanical systems are to be removed. This includes the removal of asbestos materials/mold and hazardous materials from ductwork or pipes in a building when the building is to be demolished at the time or at some close future date.

ASBESTOS - MECHANICAL - removal of asbestos material from mechanical systems, such as pipes, ducts, and boilers, where the mechanical systems are to remain.

CERAMIC TILE FINISHER

The grouting, cleaning, and polishing of all classes of tile, whether for interior or exterior purposes, all burned, glazed or unglazed products; all composition materials, granite tiles, warning detectable tiles, cement tiles, epoxy composite materials, pavers, glass, mosaics, fiberglass, and all substitute materials, for tile made in

tile-like units; all mixtures in tile like form of cement, metals, and other materials that are for and intended for use as a finished floor surface, stair treads, promenade roofs, walks, walls, ceilings, swimming pools, and all other places where tile is to form a finished interior or exterior. The mixing of all setting mortars including but not limited to thin-set mortars, epoxies, wall mud, and any other sand and cement mixtures or adhesives when used in the preparation, installation, repair, or maintenance of tile and/or similar materials. The handling and unloading of all sand, cement, lime, tile, fixtures, equipment, adhesives, or any other materials to be used in the preparation, installation, repair, or maintenance of tile and/or similar materials. Ceramic Tile Finishers shall fill all joints and voids regardless of method on all tile work, particularly and especially after installation of said tile work. Application of any and all protective coverings to all types of tile installations including, but not be limited to, all soap compounds, paper products, tapes, and all polyethylene coverings, plywood, masonite, cardboard, and any new type of products that may be used to protect tile installations, Blastrac equipment, and all floor scarifying equipment used in preparing floors to receive tile. The clean up and removal of all waste and materials. All demolition of existing tile floors and walls to be re-tiled.

COMMUNICATION TECHNICIAN

Low voltage construction, installation, maintenance and removal of telecommunication facilities (voice, sound, data and video) including outside plant, telephone, security systems and data inside wire, interconnect, terminal equipment, central offices, PABX, fiber optic cable and equipment, micro waves, V-SAT, bypass, CATV, WAN (wide area network), LAN (local area networks), and ISDN (integrated system digital network), pulling of wire in raceways, but not the installation of raceways.

MARBLE FINISHER

Loading and unloading trucks, distribution of all materials (all stone, sand, etc.), stocking of floors with material, performing all rigging for heavy work, the handling of all material that may be needed for the installation of such materials, building of scaffolding, polishing if needed, patching, waxing of material if damaged, pointing up, caulking, grouting and cleaning of marble, holding water on diamond or Carborundum blade or saw for setters cutting, use of tub saw or any other saw needed for preparation of material, drilling of holes for wires that anchor material set by setters, mixing up of molding plaster for installation of material, mixing up thin set for the installation of material, mixing up of sand to cement for the installation of material and such other work as may be required in helping a Marble Setter in the handling of all material in the erection or installation of interior marble, slate, travertine, art marble, serpentine, alberene stone, blue stone, granite and other stones (meaning as to stone any foreign or domestic materials as are specified and used in building interiors and exteriors and customarily known as stone in the trade), carrara, sanionyx, vitrolite and similar opaque glass and the laying of all marble tile, terrazzo tile, slate tile and precast tile, steps, risers treads, base, or any other materials that may be used as substitutes for any of the aforementioned materials and which are used on interior and exterior which are installed in a similar manner.

For definitions of classifications not otherwise set out, the Department generally has on file such definitions which are available. If a task to be performed is not subject to one of the classifications of pay set out, the Department will upon being contacted state which neighboring county has such a classification and provide such rate, such rate being deemed to exist by reference in this document. If no neighboring county rate applies to the task, the Department shall undertake a special determination, such special determination being then deemed to have existed under this determination. If a project requires these, or any classification not listed, please contact IDOL at 217-782-1710 for wage rates or clarifications.

LANDSCAPING

Landscaping work falls under the existing classifications for laborer, operating engineer and truck driver. The work performed by landscape plantsman and landscape laborer is covered by the existing classification of laborer. The work performed by landscape operators (regardless of equipment used or its size) is covered by the classifications of operating engineer. The work performed by landscape truck drivers (regardless of size of truck driven) is covered by the classifications of truck driver.

MATERIAL TESTER & MATERIAL TESTER/INSPECTOR I AND II

Notwithstanding the difference in the classification title, the classification entitled "Material Tester I" involves the same job duties as the classification entitled "Material Tester/Inspector I". Likewise, the classification entitled "Material Tester II" involves the same job duties as the classification entitled "Material Tester/Inspector II".



Park District Report - April 2016

There were twenty (20) calls for service in the area parks during the reporting period, which is consistent with park district activity during this time of year. The majority of the calls were minor in nature and included suspicious circumstances/persons/autos, found articles, burglary alarms, citizen assists and a fight.

There were a total of 258 park checks initiated by the patrol officers during this month. There were no patterns or crime trends discovered during this month. The numbers of calls and checks were consistent with the nicer weather and the increase in use of the parks.

The following gives more detail about several of the calls during the reporting period:

- On 04/04/16, Officer Witt was informed that a fight took place at Memorial Park. Officer Witt responded to Memorial Park and made contact with both juvenile subjects. The juveniles advised that they planned the fight due to an argument that started on social media. The juveniles were arrested and charged with fighting and sent to Peer Jury.
- On 04/14/16, officers were called to Parkview Fitness Center for a report that the odor of cannabis was coming from the men's locker room. Officers spoke to the employees and then conducted a walkthrough of the men's locker room but did not smell the odor of cannabis. Officers conducted a walkthrough of the rest of the building but did not locate the odor.
- On 04/16/16 and 04/18/16, officers responded to the Diamond Lake Sports Complex for subjects who were locked in the park due to the gate automatically closing at dusk. The subjects were let out of the park and advised of the park hours.
- On 04/26/16 and 04/30/16, officers responded to Barefoot Bay for burglary alarms. Officers checked the area and found it to be secure on 04/26/16 but on 04/30/16 they located open doors to the maintenance building on 04/30/16. The doors were later secured.

Officers will continue to perform walk-throughs at Park View to deter unwanted subjects from attending. In addition, they will continue to perform park checks at the various parks due to the anticipated increase in park use (baseball and soccer games) with nicer weather upon us.
