MINUTES

Mundelein Park & Recreation District Committee of the Whole August 8, 2022

The Committee of the Whole meeting of the Board of Park Commissioners of the Mundelein Park & Recreation District, Mundelein, Lake County, Illinois, was called to order at 7:00 p.m.

Present were Commissioners DOLAN, KNUDSON, McGRATH, ORTEGA and President FRASIER.

Staff present included Executive Director SALSKI.

Executive Director SALSKI discussed Grant Updates and stated the importance of being detailed.

Executive Director SALSKI discussed Stewardship Plan of Naturalized Open Space Area and recent complaints about the natural areas. He suggested waiting for board acceptance until staff recommended a position on standards. Commissioner DOLAN asked if any ponds were a destination. Board Members agreed minimal standards were acceptable. Executive Director SALSKI stated no ponds are maintained as a destination. Commissioner McGRATH asked the function of the ponds. Executive Director SALSKI stated District ponds are retention for the subdivisions.

Executive Director SALSKI mentioned the various facility hours. Commissioner DOLAN asked if there was an opportunity to surprise the members on an afternoon by opening up after end of season. He appreciated the members coming to the facility with challenging news in the beginning with an eventual surprise. He suggested it would be a good thank you back to the members. Executive Director SALSKI agreed with the idea and stated if staff could find enough lifeguards. He would need to check with management team. Executive Director SALSKI mentioned he would inform the Board of any decision.

President FRASIER asked if there were questions on any topics listed on the agenda. Commissioners had questions about the warning sirens. Executive Director SALSKI showed a current warning siren picture in Sheldon Woods development. Commissioners asked if it was lightning detection as well. Executive Director SALSKI stated it was tornado/emergency siren only. Executive Director SALSKI provided an update on Maple Hill with the Village cutting the grass. He reiterated the District has legally submitted paperwork to the County claiming the District does not own the property. He stated the Developer still owns the property. He mentioned there were no finalized landscape plans with the Village. Board Members agreed the District has no obligation to maintain.

President FRASIER repeated the motion, asked if there were any additional corrections or additions. A roll call vote was taken to approve Ordinance 22-08-01-O with Commissioners KNUDSON, ORTEGA, DOLAN, McGRATH, and FRASIER voting yes.
